Program Length	The typical exchange program is one academic semester, however, some students opt to study for two semesters (one year) if permitted by Chicago-Kent and by the student's home school. Nominated students should indicate on their application form their desired program length.
Visa Requirements	Students who plan to complete the one semester exchange option will be provided an application form for the U.S. J-1 Student Exchange Visa, should they be admitted to the program. Those who plan to complete the full year will be issued an application form for the U.S. F-1 Student Visa.
Health Insurance	All international exchange students are required to purchase the IIT Student Health Insurance plan unless they can provide proof of health coverage from a U.S. health provider subject to the approval of the IIT Student Health Center. The estimated cost of this Health Insurance plan is \$994 USD for the one semester option and \$1800 USD for the full year.
Accommodation	All international exchange students are required to find and set up their own student housing. The law school does not assist with this process. You can find more information about some potential housing options here: Housing Guide in Chicago
