<u>INITIAL READING ASSIGNMENTS – SUMMER 2024</u> May 12, 2024

Listed below are the initial reading assignments we have received to date. Not all professors submit initial assignments, so do not be concerned if there is no listing for one or more of your courses. If we receive additional assignments, they will be emailed to students enrolled in the course(s). Even if a course is not listed here, materials for the course should be available through the university's virtual bookstore.

Administrative Law – Prof. Krent

The casebook is Gellhorn and Byse's Administrative Law (12 th edition 2018). Note that there is a newer edition, but far more expensive. Additional readings can be found on the Blackboard site. Each assignment represents a unit of reading – we may well cover more or less than one unit per class. For the first week, please read 20-31; 791-813 in the casebook, Gundy on Blackboard, and then continue with 830-48; 860-68 in the casebook.

Commercial Law: Secured Transactions – Prof. Walters

The required textbook for Secured Transactions is <u>BARRON</u>, <u>WESSMAN & PARDO</u>, SECURED TRANSACTIONS – PROBLEMS & MATERIALS (West Academic, 4th ed. 2021).

The textbook will be used in close conjunction with the Uniform Commercial Code ("UCC"). Any current version of the UCC will suffice though a version that includes the Official Comments is preferable. You can access the full text of the UCC online including the Official Comments on either Westlaw or Lexis+. You can access the current statutory text of the UCC online without the Official Comments at https://www.law.cornell.edu/ You are welcome to refer to any of these versions in preparing for class, during our live class sessions, and in the final exam. Keep in mind that versions that include the Official Comments are somewhat superior to those that don't have the Official Comments. If you prefer to have an up-to-date hard copy of the UCC inclusive of the Official Comments (and many students have told me in the past that they find it more helpful during their preparation and in class to refer to and annotate a hard copy), I recommend STEVEN D. WALT, COMMERCIAL LAW: SELECTED STATUTES (Foundation Press 2023-2024 ed.)

Before the first class, please do the following:

*Familiarize yourself with the class site on Canvas. The school is transitioning from Blackboard to Canvas over the summer. You can access Canvas through the Illinois Tech app suite, the same way as you currently access your Chicago-Kent gmail and Blackboard.

For the first class, please read the Introduction and pages 3-65 in Michael Bazyler, *Holocaust, Genocide, and the Law* (Oxford, 2016).
