Section A: Identity and Statement of Educational Purpose

(To Be Signed at the Institution)

You must appear in person at the Office of Financial Aid at Illinois Tech's Conviser Law Center, Chicago-Kent College of Law to verify your identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of your photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID.

In addition, you must sign, in the presence of the institutional official, the Statement Of Educational Purpose provided below. Your submitted form MUST have a "wet" signature. If your form does not have a "wet" signature, you will be asked to complete and submit a new Verification Worksheet.

Section B: Identity and Statement of Educational Purpose

(To Be Signed in the Presence of a Notary)

If you are unable to appear in person at the Office of Financial Aid at IIT's Downtown Campus, Chicago-Kent College of Law to verify your identity, you must provide to the institution:

- (a) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to a driver's license, other state-issued ID, or passport; and
- (b) The original Statement of Education Purpose provided below, which must be notarized. If the notary statement appears on a separate page than the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized.
