Congratulations, and welcome to the Illinois Institute of Technology!

The Student Health & Wellness Center (SHWC) is a health and wellness facility at Illinois Tech. We are located at the corner of 35th and State Street on the 3rd floor of the Michael Paul Galvin Tower within the Mies Campus.

The SHWC provides on campus health, counseling and outreach services. Services are available for all students regardless of having the Illinois Tech student health insurance coverage. In addition to the counseling services provided on campus, the SHWC has partnered with Skylight Counseling <a href="https://lincolor.org/lincolor.

SHWC clinicians are available Monday through Friday from 8:30 AM through 5:00 PM by appointment and for walk-in emergency situations. Appointments may be scheduled by calling (312) 567-7550.

There is no charge for counseling services, although there may be charge for medical appointments, prescription medications, labs, diagnostic testing and/or referrals to providers in the community. In addition to individual appointments, the SHWC also offers outreach programs to Illinois Tech students. Outreach includes workshops on topics such as stress management, time management, health fairs, self-care techniques and overcoming test anxiety, as well as other topics.

For students who have preexisting conditions, both psychological and physical, and/or have been receiving treatment prior to attending college, continuation of treatment is usually recommended. Our staff is happy to speak with students about this or other issues and how we can facilitate this transition while also abiding by state and federal HIPAA and FERPA guidelines. All Clinical services are **CONFIDENTIAL**. Information communicated to both Skylight Counseling and SHWC's staff will not be disclosed to anyone outside the SHWC without written consent from the student. There are rare exceptions to this policy, such as when there is a concern for the individual's risk of hurting him/herself or someone else.

Student Health Insurance

Illinois Tech partners with Aetna Student Health to provide health insurance to the students of Illinois Tech. All students registered for one academic credit hour or more are automatically enrolled and charged for the student health insurance plan during our fall and spring term only.

All students registered for one academic credit hour will be automatically enrolled in the Aetna Student Health Insurance Plan and billed \$2,343.00 for the annual coverage. If the student wishes to utilize private benefits and would like to opt out of the Aetna Student Health Plan, they

Immunizations

We know that proving immunity from communicable diseases is not the first thing on most people's minds. However, we at the Student Health and Wellness Center, feel passionately about promoting the health of our students. All incoming students are required to submit documentation that they are compliant with University and State of Illinois Immunization requirements.

So here is what you need to know:

- The State of Illinois dictates that all students are required to present proof of immunity from measles, mumps, and rubella (MMR), as well as present proof of their primary Tetanus/Diphtheria/Pertussis (TD/TDaP) series (3 injections) and a Meningococcal Meningitis vaccine (if you are between the ages of 16-22).
- In addition, international students must and have a Quantiferon Gold or TSPOT blood test to rule out Tuberculosis disease. If the blood test is positive, the student will need to obtain a chest x-ray.
 - o Please note: We DO NOT accept tuberculosis (TB) skin tests.
- All students must follow the steps outlined at http://www.iit.edu/shwc/health-services/
- Students who are not properly immunized or who do not have proof of immunization are required to obtain any missing vaccines. They may receive either of the aforementioned immunizations and/or the TB screening at the SHWC by coming in during our walk-in immunization time(s).
- Please note appointments are required.
- Failure to comply with the immunization requirement(s) will result in an immunization hold preventing registration for the subsequent semester.
- The hold will be lifted when the student becomes compliant or "in-progress" towards compliance with the immunization requirement(s).

The Student Health and Wellness Center utilizes **Med + Proctor**, an electronic vaccination documentation collection platform, as our innovative strategy to monitor and collect your immunization information. As you know, Illinois state law requires documentation of vaccinations when entering a secondary institution. Med + Proctor is **HIPAA- and FERPA-compliant**.

This system for monitoring immunization compliance will **streamline your immunization compliance process** and help you **avoid registration holds**, so you can focus on other important matters as you prepare for a successful academic journey at Illinois Tech.

For your convenience and to ensure you have complete control of your medical records, there is a **one-time \$10.00** fee to access Med + Proctor's services, which includes:

- 48-Hour Turnaround Time on document review
- Epic and State Immunization Registry Search for faster verification
- Lifetime Access to Your Immunization Records, even after graduation

Through this process your documentation is handled efficiently and stays accessible whenever you need it—whether for study abroad, employment, or other health records needs.

How to Use Med + Proctor

- 1. First, set up your **hawk.lLTech.edu** email account.
- 2. Go to the Illinois Tech Portal and log into your account.
- 3. Search for "**Med + Proctor**" on the Illinois Tech Portal to register and start a new account.
- 4. You can save this as a shortcut by clicking the "star" next to MedProctor.
- 5. Follow the on-screen instructions.

Upload your **completed immunization forms**, which must be **stamped and signed** by your medical provider.

To ensure efficient processing, please do not bring or email your forms to the Student Health and Wellness Center. All forms must be uploaded online to Med + Proctor.

Once submitted, your documents will be reviewed for compliance. You will receive updates and any action items via your **Illinois Tech Portal email**. It's important to regularly check your email to ensure you stay in compliance and avoid holds.

You can also monitor your account by clicking on the **STATUS** or **MESSAGE** tab at the top of your Med + Proctor page.

We encourage you to submit your information **as soon as possible**. Verification of documentation typically takes 48 hours. However, holds may take up to 3-5 **business days** to be removed after submission.
