

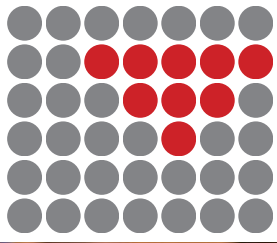

# Welcome from the Director of the Public Interest Center



Dear friends,

Welcome to the 2026 Public Interest Awards - we are so glad you could join us this evening to celebrate another wonderful year of impactful pro bono work in the community. We hope you will find joy and inspiration tonight as you learn about the many ways Chicago-Kent students are making an impact. A special thank you to tonight's sponsor, the trial law firm of Passen Powell and Jenkins for supporting our work.

This has been an exciting year, with several new initiatives that are allowing us to expand our pro bono opportunities and engage more students.

In the fall semester, we began using Paladin, a new system that empowered Chicago-Kent law students to do more pro bono, more efficiently. Paladin centralizes pro bono opportunities, facilitates student volunteer matching, and enables students to track their progress towards completing 50 hours or more of pro bono. By using this system, we were able to determine the 2026 graduating class completed 10,182 hours of public service. The Class of 2026 has defined an important goal that we are excited to build upon in future years. Congratulations to the Class of 2026!

Over the winter break, we began a new partnership with Instituto Del Progreso Latino, with 16 Chicago-Kent students volunteering for a DACA Clinic hosted at their organization. Since then, students have volunteered monthly in Instituto's citizenship workshops. We are excited to celebrate student Gabriela Treviño-Gutiérrez and alumni Enrique Espinoza tonight who have made protecting immigrant communities a vital part of their work.

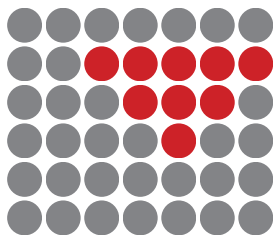
Our increased engagement with the Legal Aid Society began last year at the Chicago Bar Association/Chicago Bar Foundation Pro Bono Fair when the students' enthusiasm to volunteer with the Legal Aid Society's Elder Justice Initiative Power of Attorney Clinic resulted in our first-ever Spring Break Public Service Week. While last year we were proud to offer two opportunities, we are excited to share that this year we expanded Spring Break Public Service Week to offer support to five local non-profit organizations. ## 2026 Vivien C. Gross Pro Bono & Public Interest Leadership Award



The Vivien C. Gross Pro Bono & Public Interest Leadership Award recognizes a graduating law student who has made outstanding contributions to public interest law through their pro bono contributions as well as leadership. The award, formerly known as the "Pro Bono & Community Service Leadership Award" has been renamed this year to honor Professor Gross for her significant contributions to public interest law.

## 2026 Vivien C. Gross Pro Bono & Public Interest Award: Gabriela Treviño-Gutiérrez

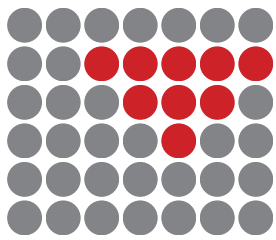


This year's winner of the Vivien C. Gross Pro Bono and Public Interest Leadership Award is Gabriela Treviño-Gutiérrez. Gaby is deeply committed to Public Interest Law and Pro Bono as demonstrated by the copious amount of pro bono engagement, public interest internships, and leadership roles she has had throughout law school.

Gaby has volunteered 403 hours with a stunning **24 different community organizations** in law school - with the majority of those hours spent at Ascend Justice, New Mexico Immigrant Rights Center, Pilsen Food Pantry, the Children's Legal Center, National Lawyers Guild, the Self-Help Resource Center, Hispanic Lawyers Association of Illinois, the Immigration Law Clinic, and Legal Aid Chicago.

Gaby is also a leader at Chicago-Kent, serving as president of the Hispanic Latinx Law Student Association; and on the board of the National Lawyers Guild, and Immigration Law Society. In addition, Gaby began working in the Public Interest Center during her second year of law school – providing almost all of the support for the success of last year's Public Service Day - and has organized countless pro bono projects for her peers.

Gaby will graduate with the Public Interest and Labor/Employment Law Certificates. As a dedicated Public Interest Leader and advocate; she has a bright future.

## 2026 Ronald W. Staudt Public Interest Partner Award: Legal Aid Society of Metropolitan Family Services



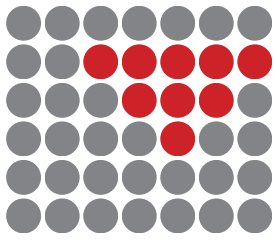
This year's recipient of the Ronald W. Staudt Public Interest Partner Award is the Legal Aid Society of Metropolitan Family Services. This award will be accepted by alumni Loren Gutierrez.

We are proud to celebrate the Legal Aid Society, the oldest provider of legal aid in Illinois - founded in 1886. We have shared legacies. Chicago-Kent, then known as Chicago College of Law, was established in 1888 - providing legal training to working men and women who sought to become attorneys.

The Legal Aid Society was nominated and selected because of their important work providing equal access to justice for all - with a particular focus on the most vulnerable communities, including those who are impoverished, the elderly, and victims of violence & crimes. Throughout the years, many students have served as legal interns at their organization, where they have had exceptional experiences serving the most vulnerable - and some have joined their team as attorneys.

Over the past two years in particular, our engagement has deepened, with clinics during our Spring Break Public Service Week. Recently, thanks to Paladin as a tool to help us connect, we have students volunteering with Legal Aid Society clinics on a regular basis throughout the year.
